Reservations require a \$100 deposit accompanied by this signed contract.

If the Buyer's chosen sex of the kid is not available from their chosen kidding, Buyer has the option to roll the reservation to another kidding or their deposit will be refunded.

8 Gables reserves the right to retain any kid from any breeding.

Reserved kids MUST be picked up by 14 days after birth.

Deposit refunds are not given due to the Buyer changing their mind.

Seller does not offer any health or wellness guarantees after the goat has left our Farm since we cannot control the management of said goat(s) once it leaves our farm.

Any kids who are the result of a doe purchased bred will carry the herd name: 8Gables and the Buyer's tattoo numbers

Goats will not leave the farm until full payment is received.

8 Gables requires a \$100 deposit each to hold any doe, buck or kid.

Reserved kids/goats not picked up after 14 days Buyer will be charged \$3/day board or reservation will be forfeited and the kid/goat will be placed for sale.

If a doe or buck is sold as a pet no registration papers will be given to Buyer, only a bill of sale.

Buyer has read separate "SALES TERMS" posted.

This Agreement shall be governed by the laws of the State of California, County of Solano.
